

# Privacy Notice

## Introduction

We believe that transparency is important and appreciate that you trust us with information that is important to you. We want to be open about how we use it and so this privacy notice will let you know about the data we collect, how we use it, the controls we give you over your information, and the measures we take to keep it safe.

## Information we collect

When you start to access our services, we collect a lot of personal information including your name, address, telephone number and email address. We also collect some more sensitive information like if you have a disability or support need and the kind of support you receive. This more sensitive data is classified "Special Category Data" by the Information Commissioners Office.

## Why do we collect this information?

The information we collect is used to match you with a Support Worker / Mentor / Tutor and for them to have the information they need to provide your support.

We also use this information to communicate with you including arranging your academic support sessions, asking for your feedback and letting you know about other services we provide.

While you are getting support, your Support Workers / Mentor / Tutor will complete work plans and session logs. They will also create timesheets which we will use to invoice Student Finance England.

## How do we keep your information safe?

All of your information is kept in a file on our secure company shared drive or on Cudos, an online system which we use to arrange, manage and invoice for your care. The shared drive and Cudos can only be accessed with a username and password and access rights are restricted only to employees who need to see it.

## Who else might get to see your personal information?

- **The Department of Education**  
The Department of Education oversee the quality of support we provide so they may send an auditor in to check that what we are doing is legally compliant but also fits with their guidance. As the auditor would be able to see both your personal information and
- **Safeguarding**  
We have a legal obligation to share information with the local adults or children's safeguarding team or even the police if we felt that you or others were at risk of harm.
- **The person who funds your support**  
We would have to send your name to the person who funds your support so that we can invoice for the work. For examples Student Finance England or your University

## Your rights in relation to your data

- **The right to be informed**  
You have the right to know what information we hold about you, how we store it and who has access to it. That is why we are giving you this privacy notice.
- **The right to access your personal information**  
You have the right to be able to access any personal information we hold about you. If you wish to do so, you need to write to us at the address at the bottom of this document.

- **Your personal information being correct**  
You have the right to ensure that the information we hold about you is correct. If you find that it is not, you have the right to have it changed. We will make any changes requested as soon as possible.
- **The right to erasure**  
Although for some of your personal information, we legally have to keep it and share it with others, there may be some information you could ask us to delete. If you wish to request that your data is erased you can write to us at the address at the bottom of this document. We will write back to you to let you know what we have been able to delete and what we have had to keep, why we need to keep it and how long we will keep it for.
- **The right to restrict processing**  
In some circumstances you can ask us to restrict the way we use your data. This is usually just for a short period of time for example if you don't think your data is right and so while we update it you and want us to stop using it.
- **The right to data portability**  
This means that you can ask us to provide any data you have given us to others.
- **The right to object**  
You have the right to object about how your data is used. For example, you should let us know if you don't want to receive any information relating to other services we offer.

## Data Retention

Your personal data will be kept by us for as long as you are accessing the service. Once you stop accessing the service, we will only keep your data for as long as we need to in order to comply with the law and best practice. Any data that we don't have an obligation to keep, we will destroy once you have stopped accessing our services.
